

SPEAKER PROGRAM

The Transportation Energy Institute welcomes the opportunity to share insights with interested stakeholders and is often asked to speak on various topics related to the transportation energy sector. In a given year, the Institute typically receives more than 50 invitations to address critical issues facing the market, leveraging the Institute's peer-reviewed research findings along with additional third-party research, data analysis and input from stakeholders affected by the issues.

The research of the Transportation Energy Institute is offered to the public at no cost, yet producing the research is not free. The speaker fees presented below serve to support the ongoing research of the Institute and are deposited into the organization's Research Fund. Contributions can be made directly to the Fuels Institute or through an affiliated charitable organization which supports the Institute's research.¹

PRESENTATION OPTIONS

CONFERENCE PRESENTATIONS

The Transportation Energy Institute is available to deliver up to one-hour presentations to your meeting or conference, depending on schedule availability. Available speakers include Institute staff or potentially certain members of the Institute Board of Advisors.

These Special Presentations last approximately two-hours and include more engagement between the speaker and the audience to deliver a more tangible benefit for your organization. CUSTOMIZED WORKSHOPS
